INTRODUCTION

Reference to the Constitution

Section 32 of the Constitution of the Republic of South Africa, No. 108 of 1996 ("the Constitution") provides:

S32(1) Everyone has the right of access to -

- (a) any information held by the state; and
- (b) any information that is held by another person and that is required for the exercise or protection of any rights.

S32(2) National legislation must be enacted to give effect to this right, and may provide for reasonable measures to alleviate the administrative and financial burden on the state.

The Promotion of Access to Information Act, 2 of 2000 ("the Act"), was enacted on 3 February 2002 to give effect to section 32 of the constitution, that is giving effect to the constitutional right of access to any information held by the State and any information that is held by another person and that is required for the exercise or protection of any rights. Where a request is made in terms of this Act, the private or public body to which the request is made is obliged to release the information, except where the Act expressly provides that the information must not be released. The Act sets out the requisite procedural issues attached to such request.

The Act came into effect on 9 March 2001 with the exception of sections 10, 14, 16 and 51 which sections were brought into operation on 15 February 2002.

Reference to Living Matter Landscaping CC

5. HOW TO REQUEST A RECORD. A DESCRIPTION OF THE SUBJECTS OF THE RECORDS HELD BY LIVING MATTER LANDSCAPING CC AND THE CATEGORIES IN WHICH THESE SUBJECTS ARE CLASSED. [Section 51(1)(e)]

5.1 How to request a record

See prescribed request form in Section 9 (Page 8)

Section 53 prescribes that the requester must use the prescribed form to make the request for access to a record. This must be made to the Information officer of Living Matter Landscaping CC The request must be made to the address, fax number or electronic mail address of the Information officer of Living Matter Landscaping CC as mentioned in point 1) on page 3.

The requester must provide sufficient detail on the request form to enable the Information officer of Living Matter Landscaping CC to identify the record and the requester. The requester should also indicate which form of access is required. The requester should also indicate if s/he wishes to be informed in any other manner and state the necessary particulars to be so informed.

The requester must identify the right that s/he is seeking to exercise protect and provide an explanation of why the requested record is required for the exercise or protection of that right.

If a request is made on behalf of a person, the requester must then submit proof of the capacity in which the requester is making the request to the satisfaction of the Information officer of Living Matter Landscaping CC.

The Information officer of Living Matter Landscaping CC must notify the requester (other than a personal requester) by notice, requiring the requester to pay the prescribed fee before further processing of the request.

The request fee for private bodies is R50. The requester may lodge an internal appeal or an application to the court against the tender or payment of the request fee.

If the request is granted then a further access fee must be paid for the reproduction and the search and preparation, and for any time that has exceeded the prescribed hours to search and prepare the record for disclosure. The Information officer of Living Matter Landscaping CC will then make a decision on the request and notify the requester in the required form.

5.2 Categories of records held by Living Matter Landscaping CC

5.2.1 Web page and library records

Web page

The web page, www.livingmatter.co.za is accessible to anyone who has access to the Internet.

Library

The entity does not have a library.

5.2.2 Other records Operational information


